### WAIVER, INDEMNITY, DEFEND AND HOLD HARMLESS

In consideration of being allowed to participate in the Adopt-A-Place program, the Adoptee agrees that it shall have no recourse, legal or otherwise, and promises that it shall not bring action or demand against the Office of the Mayor of Saipan for participating in the program, and hereby releases and forever discharges and agrees to indemnify and hold harmless the Office of the Mayor of Saipan, the CNMI Government, their successors, employees and assigns, from any and all injury or loss and all liability for injury or loss to persons or property which occur on the adopted site or which arise out of or in connection with any activities under this program.

In addition, the Adoptee also agrees to defend the Office of the Mayor of Saipan, the CNMI Government, their successors, employees and assigns, from and against any claim, demand or lawsuit with respect to the subject of the indemnity contained herein, whether or not such claims, demands or actions are rightfully or wrongfully brought or filed and against all costs incurred by the Office of the Mayor of Saipan, the CNMI Government, their successors, employees and assigns therein. In case a claim should be brought or an action filed with respect to the subject of indemnity herein, the Adoptee agrees the Office of the Mayor of Saipan, the CNMI Government, their successors, employees and assigns may employ attorneys of their own selection to appear and defend the claim or action on their behalf, at the sole expense of the Adoptee. The Office of the Mayor of Saipan, the CNMI Government, their successors, employees and assigns, at their own option, shall have the sole authority for the direction of the defense, and shall be the sole judge of the acceptability of any compromise or settlement of any claims or actions against them.

Adoptee further acknowledges its duty to comply with all Commonwealth laws and the authority of all CNMI agencies in carrying out its activities as Adoptee, and affirms that it will diligently perform all requirements of, and conform its operations to all, applicable laws, regulations, and agency directives.
