All claims for the parties involved are hereby released.

I hereby certify that my child is fully capable of participating in the activities of this said 2025 Saipan Mayors Youth Sports program and that my child is healthy and has no physical or mental disabilities or infirmities that would restrict full participation in the activities, except as made known to the Committees, Sub-Committee, or the officials of the organization.

I further agree on behalf of myself and myself and my child listed below, that I shall hold harmless and fully indemnify the parties from any and all claims, personal injuries, damages, costs including attorney fees, and causes of action which may arise from any cause of action made by me or by, through or on behalf of my child, even if the damages, injuries or death are caused in whole or in part by any of the persons or entities hereby released.
